Juried Artist Member (JAM) Benefits

Artists who have attained the distinction of a Juried Artist Member will receive the following benefits with their annual membership:

- Eligible to be included in a Juried Artist Member Invitational Show at the gallery.
- Eligible to submit 4 pieces in the gallery Browse Bins.
- Eligible to submit up to 20 greeting cards for sale in the gallery.
- Direct link from WAA website to Juried Artist Member's website.
- Artist's biography/statement featured in the association's member reference book.
- The opportunity to display and sell artwork at offsite locations.
- Eligible for Featured Juried Artist of Month on our website.
- Application fee discount on a booth at the Wickford Art Festival.
- Discounts on WAA classes and workshops.

Juried Artist Member membership dues are \$60 annually (July 1st – June 30th).

WAA bylaws state that General Artist Members in good standing for a minimum of 6 months may be considered for Juried Artist Membership. Membership dues must be up to date as of May 1, 2020 and current for 2020-2021 for the November 17, 2020 panel.

Schedule:

1. Reserve your space 401-294-6840 – WAA has limited spaces available for JAM panel consideration.
2. **Deliver this completed application with your art work in one medium (see page 2) to WAA on Tuesday, November 17th between 11 AM and 3 PM.**
3. The jury panel, consisting of three (3) WAA Juried Artist Members, meets Tuesday evening.
4. **Work must be collected the following day on Wednesday, November 18th, 11 AM and 3 PM.**
5. The jury panel will contact the artist with their decision within three weeks.
